



NAR Issues Statement on Supreme Court's CDC Eviction Ban Ruling

A majority of the Supreme Court agreed that the Centers for Disease Control and Prevention lacked authority to implement a blanket, nationwide eviction moratorium.

With the support of NAR, the Georgia and Alabama Associations of Realtors® challenged the orders in federal court. In May, a U.S. federal judge sided with housing providers, ruling the moratorium unlawful.
